2. Audit type and man-day(s):

The announced social compliance audit was conducted by QIMA ethical auditor Dennis Yang on April 22, 2021. Auditor arrived at the factory at 8:30 am and started opening meeting, then finished the closing meeting at 17:00 on April 22, 2021 and then left the factory.

3. Negative findings:

Part A LVMH Social Grid: Compliance level is Need Major Improvement, Details of NCs as below:

- Item 1 Health & Safety:
- 1.No occupational health examinations for ten workers contacting hazard elements.
- 2. No ergonomics with some positions, such as no back rest chair to long standing workers.
- 3. Inadequate PPE use
- 4. No toilet paper and soap at toilet.

-Item 2 Child Labour: No negative finding was identified.

-Item 3 Forced Labour: No negative finding was identified.

-Item 4 Working Hours:

Monthly overtime hours exceeded the legal requirement of 36 hours per month. According to the attendance records of recent 3 months for 10 randomly selected workers, details were 60-62 hours in December 2020 (random month) and 62-66 hours in August 2020 (random month).

Remark: Factory did not obtain Consolidated Working Hour System Approval, and overtime of February 2021 (Current month) was 12-14 hours.

- Item 5 Wages & Benefits:

It was noted that only 26 out of 97 employees (26.8%) covered in pension, medical, unemployment, work-related injury and maternity insurance of social insurance scheme based on latest social insurance receipt of April 2021

- Item 6 Workers' Rights: No negative finding was identified.
- Item 7 Management System: No negative finding was identified.
- Item 8 Anti-Corruption: No negative finding was identified.

Part B Questionnaire 10 questions: Compliance level is acceptable, scoring is 82.9%.

Part C Supplier transportation on its subcontractor Networks: Compliance level is Satisfactory. No negative finding was identified.

Part D Collaborativeness: Satisfactory. No negative finding was identified.

4. Neighbour Audit Review:

17:30 Left the factory after finishing the audit and start the neighbors audit without noticing the factory.

17:35 Some workers went out the factory after working time.

Departure time: when you finish and left the site (e.g. 6:20pm)

Interview with neighbor shops:

17:35 There are another factory (Dongguan Guike Electric Equipment Factory) nearby the audited factory, interviewed several people from the other factory, they told the auditor that the audited factory usually overtime till 20:30 around. Saturday usually overtime.

<u>Interview with neighbor shopkeeper</u>: 18:00 Auditor talked with shopkeeper (Remark: There was one small neighbor shop(Tianfu Grocery) located nearby the factory gate.) The shopkeeper knew the factory working time, just because if workers were avaiable at the facility, workers at this factory usually shopping at this shop when they after work at PM 8:30 and usually overtime on Saturdays.
